Readers are interested and want to know how the story ends. They want to know whether the ending of the novel satisfies readers of popular literature in the West. When you read the book that you like, you will react to issues so that it will have a positive effect and satisfaction. Perhaps, from this literary work, the author hopes to stop racist behavior. It can be started by changing our views and what is on our minds. However, as Donald Noel (1972) has argued, racism is a characteristic. It is because racism is a culturally and historically limited phenomenon. The term "racism" is often used to describe the hostility and negative feelings of an

ethnic group towards other ethnic groups. In fact, in everyday life, racism is widespread. Antipathy (dislike) towards a group should no longer be just a discourse. It has led to destructive attitudes and behavior patterns. Race with the meaning of racism, refers to culturally different groups of people based on physical characteristics that cannot be changed. So race in racism is determined socially based on physical characteristics (Daldjoeni, 1991:82).

Adunni as a woman who has rights is confused by a culture that is seen as normative. The story raised by the author became popular because of the truth of a normative reality. It can be explained through the theory of racism. The theory proves that everyone has the same rights. Everyone gets what they want without seeing things end with bad consequences.

The Abi Dare novel explains that women from Nigeria are not allowed to study in school. It is not the desire of the characters in the story. The author of the novel realizes that it can become an issue. It is hotly discussed. That's because there is still such a normative culture. Quoted from the amnesty id article, those who acknowledge or practice racism argue that members of low-status races should be limited to lowstatus jobs. Whereas members of the dominant race must have exclusive access to political power, economic resources, high-status jobs, and other civil rights. Although racist ideology may be fading nowadays, racial discrimination based on skin color continues. It makes its members have no access to education, jobs, and various other opportunities. One of them happened in England. In 2017, the UK government identified more than 4000 people in the "Gang Matrix". It was a list of names of youths suspected of being gang members. Many people enter the list because they have seen videos and heard music that is considered 'dangerous'. They get the stigma that they have the potential to commit violence. Keep in mind that 78% of the people on this list are black. Only 27% of black youth on the list have been convicted of serious crimes. The quote above explains factually what is happening in society. It became one of the ideas for the writer which then influenced the popularity of the novel. The novel also explains that her father forced her to marry to earn a lot of money. Not only getting married but also getting an inheritance if Adunni gives birth to a son. Viewed from a postmodern perspective, this controversy is one of the assumptions of the people who read the literary work. This is an urgency in society that must be resolved immediately. Gidden also argues (1990) that the term refers only to changes in institutions. It is a condition where the economy, politics, and culture are following the circumstances or conditions. That means that racism is also not governed by the principle of continuous production of goods. The production and reproduction of information with a concept and form of society no longer work to meet needs but to fulfill lifestyles. That means the characterization of Adunni's father still wants money in all situations and does not think about his son's wishes. This can also be seen in a novel review written by a good read named Lisa of Tro. He said that "however, at the age of fourteen, her father married her off to Morufu, a man old enough to be her father and who already had two other wives. What is in store for Adunni?" (2023). He explained that it is not enough for a husband to just be husband and wife, so what are you waiting for? Referring to something normative that he should have freedom. It can be a paradox that what the author writes can impart a principle. It is a natural thing if a father wants his child to live properly after the death of his mother. It makes the reader feel sorry.

In Chapter 4, readers can find written expressions in conveying literary works with language identity.

"Adunni, God knows I will use my last sweat to be sending you to school because I am wanting you to have a chance at life. I am wanting you to speak good English because, in Nigeria, everybody is understanding English, and the better your English speaking, the better for you to get a good job." (p.26)

The quote above explains that identity will get existentialism by using language as a construction by dominating. By looking at this existentialism, can language become an existential identity for negroids. This is what causes the sustaining racism. It refers to the number of negroids or African-Americans who master language and education as a reference for modernity. Then postmodernism works to improve the perspective of human knowledge. Postmodernists focus on awareness of social inequality. It deconstructs traditional assumptions about knowledge, education, schools, and teaching. Society likes a form of writing that is very poetic and gives the impression of an allegory in it. According to Lyotard, he believes that there is no unity and essence of language. For him, language is "agonistic". It is a space or place of disputes and conflicts that can never be resolved. The differences that exist cannot be compared. No amount of play, language, or other phrases can reconcile these differences. The language game conveyed by the author in expressing the problem of injustice as a woman is unique in the production of literary works. Racial discrimination is not a new phenomenon in the US, in fact it has been going on for hundreds of years. The stereotype of society still considers that white people are superior and black people are inferior, and this is still difficult to eliminate until now (Sutopo, 2016). There are so many incidents and examples of attitudes that are not so good in responding in life and society has labeled it as a habit. Statistics presented by the BBC (2020), related to the incidence of shootings to death by the US police, show that the deaths by US police show that African-Americans are more more likely to be shot dead, especially when compared to their overall population In this case it is the same as what happens in novels, depending on what the content of the novel is so popular because their tastes are still not finished to consume literary works in the views of US people towards African Americans towards The following are excerpts from the novel.

From all these important impacts, there are people who criticize which are divided into three groups, namely the New Age metaphysics group that wants to return to pre-modern patterns, the deconstructionist group that stems from language as a human-forming structure, and the group that wants to revise modernism by still using modernism as a foundation and reducing the negative consequences there of (Sugiharto, 1996: 32-34). from the above quote it can be said that these people and people can possibly be said to be postmodernists (Hidayah, 2019: 139). The overall impact of the postmodern state is that many other ethnic groups share the same deep alienation, hopelessness, and uncertainty as black citizens.
